Dear Senator Deuell:

Thank you for your letter alleging that U. S. Congressman Martin Frost and his political action committee, Lone Star Fund-Nonfederal Account, have "accepted and co-mingled corporate funds that were sent directly to candidates in Texas campaigns in the 2000 and 2002 election cycle."

I appreciate your interest in the enforcement of our state law that prohibits corporations and labor organizations from contributing to candidates for public office. Such vigilance is the price of freedom from domination of our electoral processes by special interests.

Shortly after receipt of your letter the Public Integrity Unit of this office began an investigation into the allegations contained in your letter to determine whether any offenses were committed within our jurisdiction to prosecute where venue lies in Travis County.

We will notify you of our findings as soon as we have concluded the investigation.

Dear Mr. Earle:

This letter serves as a means to lodge a formal criminal complaint against U.S. Congressman Martin Frost and his political action committee "Lone Star Fund -- Non-federal account" (EIN 52-2248343).

From a review of publicly available documents available on the website of the Internal Revenue Service, it appears that the Lone Star Fund Non-federal account, controlled by Congressman Martin Frost, has accepted and co-mingled corporate funds that were sent directly to candidates in Texas campaigns in the 2000 and 2002 election cycle. Texas law is clear: direct or indirect corporate or labor contributions to candidates is a felony offense.

As an example, the Lone Star Fund's July 1, 2000 - September 30, 2000 form 8872 filing illustrates potential abuses. The total amount of reported contributions is \$256,8000 while the total amount of reported expenditures is \$127,108. Significantly, of the reported contributions only about \$60,000 is from individuals; the remained is from corporations, associations or labor organizations, including \$10,000 from Enron Corporation and various plaintiffs injury lawyers. Of the reported expenditures, \$63,281 was transferred to the Lone Star Fund's federal account, which, questionably, shares the same EIN as the non-federal account. The bulk of the remaining expenditures went directly to Texas candidates and general purpose committees, including the "Pete Laney Campaign" and the Texas Partnership PAC, also controlled by former Texas House Speaker Pete Laney. The questions that can only be answered through the investigative authority of your office are these:





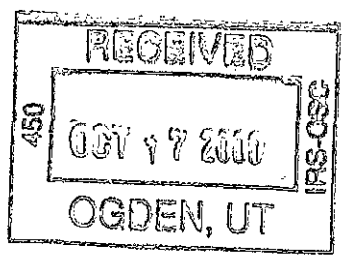
